## Board of Trustees Meeting of March 15, 2017 Action Item Auditor RFQ

As a public entity insurance group, NJSIG is required under N.J.S.A. 18A:18B-4(8) and N.J.A.C. 11:15-4.24 to obtain an annual certified financial audit performed in conformity with generally accepted accounting principles. To this end, NJSIG issued a public request for qualifications soliciting proposals from qualified firms with certified public accountants licensed in the State of New Jersey. As a result of this competitive contracting process, NJSIG received one proposal from the incumbent financial auditing firm, Nisivoccia, LLP. This proposal was evaluated using weighted evaluation criteria, and the results of that evaluation are attached. Thus, it is proposed that the contract for financial auditing professional services be awarded to Nisivoccia, LLP based on the results of the committee's evaluation.
